The Lancaster Mennonite High School boarding program seeks to be a Christian community of mutual caring and respect that celebrates diversity and provides a positive environment to study and to prepare for success in school. Most rooms in Graybill Hall house two or three students. The Residence Hall Director makes room assignments. Please direct any special requests to the Director.

In applying for admission to the boarding program, the student agrees to comply with school rules, policies, and expectations as explained in the school Policy Manual, the student handbook, and the Residence Hall handbook.

A sample of those expectations is as follows:

- It is our goal to assign all boarding students to a Sunday morning host family and church. Boarding students who are so assigned are expected to participate in this program.
- Boarding students are expected to maintain satisfactory school attendance and conduct.
- Boarding students, regardless of age, are not permitted to possess or use alcohol, tobacco, tobacco products, or illegal drugs.
- Boarding students are expected to comply with the daily residential schedule as determined by school administration and residential staff.
- Boarding students are not permitted to travel during the school year without a responsible, approved adult chaperon. (Trips home and to official U.S. contact persons are exceptions.)

Graybill Hall closes over the Thanksgiving and Christmas school breaks. All boarding students are required to do one of the following over these closings:

- Return home.
- Board with the U.S. contact person listed on the student application.
- Board with a local, approved host family. Please note that LMH does not provide host families.

I have read the information on this application and am willing to comply with the rules, policies, and expectations of Lancaster Mennonite School and Graybill Hall. I understand that failure to comply with rules, policies, or expectations may result in my being asked to leave Graybill Hall. I further understand that Lancaster Mennonite School reserves the right to interpret and apply, and modify and adopt, with or without notice, its rules and policies, in its discretion.
