- All international students are required to submit an official English proficiency test score before beginning classes. We recommend TOEFL or SLEP. Test scores will determine ESL placement and course schedule.
- In order to create a student schedule, we need to have on file official transcripts from all schools attended beginning with grade 9. The transcripts must be translated into English and include an official seal.
- All international students are covered by Student Accident and Sickness Insurance while studying at Lancaster Mennonite. You will be billed for this insurance along with your tuition.
- Pennsylvania law does not allow a student to be admitted to any school in Pennsylvania without required immunizations. Please have your physician enter all exact dates of immunizations and attach an official seal. Before beginning classes, each student must also submit a physical examination form completed by a physician.
- All international students are required to live on campus in Graybill Hall or with an acceptable local host family. Students may not live on their own or with a group of other students. Lancaster Mennonite School does not provide host families. All students need to complete a Boarding Application or provide us with the name and contact information for the local host family.
