Accident and Sickness Medical Benefit

- \$250,000 total aggregate maximum benefit payable per Accident or Sickness.

- \$35 co-pay, then 100% of Usual and Customary charges for physician office visits
- \$250 co-pay, then 100% of Usual and Customary charges for outpatient hospital expenses, including emergency room visits

- If away from Lancaster Mennonite School, consult a physician and follow his/her advice
- Notify the Plan Administrator within 30 days after the date of injury or commencement of a sickness.
- Submit a completed and signed claim form to the Plan Administrator, ASRM, LLC, 505 South Lenola Road, Suite 231 Moorestown, NJ 08057.
- Itemized medical bills (including prescription receipt) must be attached to the Claim Form at time of submission. Claims cannot be processed from "Balance Due" statements.
